- ➤ <u>Street Paving</u> Councilman Eldridge motioned and Councilman Collins seconded to have Brian Haight, PENNDOT employee, create bid packages to pave North Buffalo Street, Sheldonia Ave, Coates Street, Hemlock Street, Forestview Street and Campbell Street.   - o Any Streets not being paved will be treated with Hot Patch by the borough DPW.
- ➤ <u>Infrastructure Improvement Financing</u>
  - o Brad Upson, Labella Engineering, is supposed to provide the borough with a bid package for slip-lining the sewer lines. The borough will discuss cost and financing with Borough Solicitor.
- ➤ 1995 White Dump Truck —experiencing a brake issue. White's Autobody quoted \$3,500 to repair
  - Councilman Collins motioned to repair the 1995 Dump Truck for \$3,500. Councilman Kohut seconded the motion. A roll call vote was taken with the following results: Councilman Dorrance Yes, Councilman Kohut Yes, Councilman Eldridge- Yes, Councilman Collins \_ Yes, and Councilman Jones Yes. Motion Carried.
